End of the First Marking Period: The first marking period will come to a close as of Tuesday, November 5. Report cards are scheduled to become available in the PowerSchool portal on November 14.

Course Prerequisites Requirements and Waiver Policy: Course selection for the 2020-2021 school year will take place in February. Many advanced courses have prerequisite academic performance requirements that must be met in order for students to schedule the courses. Please be aware of these prerequisites as the first marking period of the current school year comes to a close. The issuance of grades for the first marking period provides an opportunity for students and parents to begin to discuss possible course progression for next year. In the event that prerequisite requirements are not met, students and parents may consider a "waiver." The "Waiver Policy" provides a limited opportunity for students who approach, but do not meet, these requirements, to still select certain advanced courses. Informational Reminders

Halloween Reminder: With Halloween fast approaching, students and parents are reminded that all Halloween costumes worn to school on October 31st must be school appropriate. Please be aware when choosing your child's costume that weapons and violent themes as well as alcohol and drug themes are not permitted. Just as replicas of weapons are not allowed on school property during the regular school day, this also applies to the use of "toy" weapons. The use of masks and fake-blood face paint is also prohibited. These guidelines are intended to add to the enjoyment and safety of the occasion. Any costume that is determined to cause a disruption to the school day will not be permitted and the student will be asked to remove the costume.

Handbook Corner

Family Trips If your family is planning a trip during the school year (half day and one day trips, also), it will be necessary for you to complete and submit an Educational Trip, or College trip form at least 2 weeks prior to the absence. The necessary form may be picked up in the high school main office. Please request student work in advance of the planned trip. Students are responsible for any work missed. Absences shall be treated as unlawful until the district receives a written excuse explaining the absence, to be submitted within three (3) days of the absence. A maximum of ten (10) days of cumulative lawful absences verified by parental notification shall be permitted during a school year. All absences beyond ten (10) cumulative days shall require an excuse from a licensed physician.
